INVITATION TO BID

Supply of Furniture for Phase II (other areas), Bamyan Provincial Hospital, Bamyan, Afghanistan

Aga Khan Foundation, Afghanistan, and their appointed Project Managers, Aga Khan Planning & Building Service, Pakistan (AKPBS,P) seek bids from furniture suppliers/ manufactures for Phase II, Bamyan Provincial Hospital in Bamyan, Afghanistan. The Project is being built under a Public-Private Partnership. This phase of the hospital will have 28 beds and facilities of OPD, Physiotherapy, Cafeteria and the Administration offices. The other areas of Phase II are housed in 2,500 square meters (approximately).

The furniture requirements have been split into three packages and interested firms can apply from one to all three complete packages. AKPBS,P reserves the right to award separate packages to separate suppliers. The packages are:

a) **Movable Furniture;** b) **Fixed Furniture (Wood based);** c) **Fixed Furniture (Metal based).**

The scope of works includes supply and installation, including packing, handling, transportation of the furniture to Bamyan, including all levys, any and all expenses, such as taxes, duties, loading unloading, demurrage, etc., complete to delivery and installation in the hospital.

The Architects for the Project, ARCOP (Pvt) Ltd. have developed designs for each package. The suppliers can propose their designs, equivalent to those proposed by the Architect. However, prequalification would require for them to satisfy the Architect's intent. The contract award process would be **Three-Staged** as explained below:

- In Stage One, suppliers will take Architect's proposed design.
- In Stage Two, AKPBS,P, team will physically review the furniture proposed by the bidder.
- In Stage Three, the bidders will submit their financial proposal along with the documents indicating works executed in the past, bank statements, list of clients, etc.

Applications could be rejected at any stage; the bidders would have to accept AKPBS,P's decision as final.

Please note that AKPBS,P has the right to withdraw from this process at any stage without any obligation for expense incurred by participants. Tender Package can be collected from the below noted offices upon payment of USD 150 or equivalent in local currency after **1st June, 2016 up till 15th June, 2016**. One copy, one original and one CD, of the documents required, should be delivered to the office address below by 5.00pm on the **1th July, 2016**.
