Qualifications requirements include:

(1) The minimum required annual volume of construction work for the successful bidder in any of the last five years shall be Afghani 50,000,000.00

(2) Experience as prime contractor in the construction of at least one similar work of value – Afghani 33,000,000.00 during the last five (5) years. (to comply with this requirement, works cited should be at least 70 percent complete);

(3) proposals for the timely acquisition (own, lease, hire, etc.) of the essential equipment is as given below:

(a) Excavator 1 No.

(b) Loader (Excavator Lift capacity around 1500 kg, Loader Capacity around 1 m3) 1 No.

(c) Dump Truck (5-15 m3 capacity) 5Nos.

- (d) Roller (8-10 tons, steel tires.
- (e) Portable Concrete Mixer (0.15 0.3 m3 capacity) 3 Nos.
- (f) Water Tanker Vehicle (with a capacity of 5-25 KL) 1 Nos.
- (g) Concrete vibrator Immersion/Needle (6mm diameter) 6 set.
- (h) Generator (2Kw and 10 Kw) 2 Nos.
- (i) Water Pump (1.5in 2in) 2 Nos.

Bidders are allowed to propose different equipment with sufficient information and documents lease or own to establish that their capacity is equivalent or more than the above.

(4) Project Manager with five years' experience in works of an equivalent nature and volume, including no less than three years as Manager; Vertical structure Engineer and (QA-QC) Manager, all with three years' experience in works of a similar nature and complexity.

(5) liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any

advance payments which may be made under the Contract, of no less than the amount Afghani 10,000,000.00

(6) For detailed post qualification verification please refer to Qualification information. All bidders should prepare and fill the qualification information form.

(7) Those companies who already have a contract with Mehterlam Municipality, they will not be awarded another contract unless their performance in signed contract is satisfactory. (these criteria would be applicable for the contract award) Satisfactory performance would be defined as below:

- 1- The contractor is not behind the schedule of work by more than 10%
- 2- The contractor has not received more than 1 warning for correction of defects.
- 3- The quality of Work is in compliance with the Technical Specification.
- 4- The contractor has enough assets based on the contract law and eligibility
- and qualification.

Late bids will be rejected. Bids will be opened physically in the presence of the bidders' representatives who choose to attend in person at the address below at immediately following the deadline for bid submission on 11 Feb 2019 10:00AM In case the deadline date for bid submission/ opening is declared a holiday for the Employer, the bids may be submitted up to the specified time on the next working day.
