1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, issue no. WB522-01/13 of January 30, 2013.

The Islamic Republic of Afghanistan, Kabul Municipality has Applied a ["Grant" from the Afghanistan Reconstruction Trust Fund (ARTF) toward the cost of Kabul Municipal Development Program, and it intends to apply part of the proceeds of this "grant" to payments under the Contract for **Upgrading Infrastructure of Block (1) Gozar , D-12, Kabul City. Contract Package No. (KMDP/W-93/U)**
3. The Kabul Municipality now invites sealed bids from eligible and qualified bidders for **Upgrading Infrastructure of Block (1) Gozar , D-12, Kabul City. Contract Package No. (KMDP/W-93/U)**
4. The delivery /construction period is **11 months** from the start date.
5. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits, Dated January 2011* and are open to all bidders from Eligible Source Countries as defined in the Bidding Documents.
6. 7. Qualifications requirements include:

- (a) The minimum required annual volume of construction work for the successful bidder in any of the last five years shall be **Afghani 98,000,000.00**
- (b) Experience as prime contractor in the construction of at least one **similar work** of value – **Afghani 59,000,000.00** during the last five (5) years. (to comply with this requirement, works cited should be at least 70 percent complete);
- (c) proposals for the timely acquisition (own, lease, hire, etc.) of the essential equipment is as given below:

- (e) liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any advance payments which may be made under the Contract, of no less than the amount **Afghani 24,000,000.00**
- (f) For detailed post qualification verification please refer to Section I. - Instructions to Bidders and Section II- Bid Data Sheet of the bidding documents. A margin of preference for eligible national contractors/joint ventures shall not be applied.
