### I. INTRODUCTION:

#### 1. The Introduction of ORD

- 2.1. EOI is open for all interested Afghan companies who have registered with government of Afghanistan and have valid business license.
- 2.2. The company or individual is not listed in the sanction and embargo list of the UN Security Council #1.

#### 3. Required Documents in the following categories:

- A. **Construction building** services inclusive of community center, school, playground, surrounding wall, water point, and electricity poles.
- B. **Rehabilitation** inclusive of gravelling road.
- C. Water supply inclusive of pipe scheme, water well, water drainage canal, and water reservoir.
- D. **Agriculture services** inclusive of poultry project, greenhouses, chicken coops, and incubator machines.
- E. **Logistics services** inclusive of supply and installation solar panels system, office supply, rental vehicles, transportation, etc.
- F. **Construction Materials services** inclusive of steel reinforcement, cement, brick, stone, gravel, crush aggregate, paint, plumbing material, and electrical material.

Applications shall be evaluated in accordance with the following criteria:

- Legal status, (updated valid business license).
- Experience in similar projects in above mentioned categories is mandatory and preferred.
- List of recent three years completed projects as prime contractor.
  Project name / description, total contract price, client or contractor, project status, and location.

Only eligible and qualified companies based on above shall be invited to participate in the bidding/tender process.
