FHI 360/USWDP is looking for direct local furniture production companies/carpenters to produce locally-made furniture per specifications included in Annex 1.

I. Items Specifications

See Annex 1 for detailed specifications.

II. Minimum Eligibility Requirements Vendors

To qualify for this RFQ, the vendor must:

- Hold a valid business license
- Be direct suppliers of locally-made furniture with the production facility/workshop of their own. Subcontracting is not allowed.
- Accept all FHI 360 terms and conditions included in Annex 1, and complete the table in <u>Annex 1</u> of this RFQ.
- Provide samples of work for approval

III. Evaluation Criteria

Vendors whose samples pass the quality check and whose offer meets minimum technical specifications established in Section I and II, will be proposed for the evaluation and selected based on the lowest price. Therefore, please provide your best and final offer.

IV. Submission Requirements

Electronic Submission: Please email your offers to uswdp.org by the designated deadline. Please indicate RFQ-004282 in the subject line of the email.

- All Quotations must be **signed and/or stamped** by an authorized representative.
- Vendors can submit their prices in their quotation format, but Annex 1 must be completed (mandatory).
- Quotations must provide a complete address, telephone number and e-mail address (if applicable) of the company. Vendors that do not supply this info will be disqualified.
- Quotations should be submitted in USD

V. Tax

Withholding Tax on Subcontractor:

Government withholding Tax: Pursuant to Article 72 in the Afghanistan Tax law effective March 21, 2009, USWDP/FHI360 is required withhold "contractor" taxes from the gross amount payable to all Afghan for-profit subcontractor/vendors with aggregate amount of AFN 500,000.00 or greater and transfer this to the Ministry of Finance. In accordance with this requirement, USWDP/FHI360 shall withhold 2% tax from all gross invoices from subcontractors/vendors under this Agreement with active AISA or Ministry of Commerce License. For subcontractors /vendors without active AISA or Ministry of Commerce license, USWDP/FHI360 shall withhold seven percent 7% "contractor" tax per current Afghanistan Tax law.






Front View M1:00






3A - Drawing (3D view)
