Afghanistan Institute for Civil Society (AICS) Terms of Reference

Short Term Assignment for the development of AICS' five years strategic plan

Background

Civil society has long been a key factor in addressing a full range of issues in the social, cultural, religious, humanitarian and political life of Afghanistan. With the focus upon transition to Afghan leadership, civil society, particularly local and national non-governmental organizations (NGOs), have the potential to play an important and complementary role in Afghanistan in the delivery of the government's priority programs, in supporting improved governance, in connecting the wider Afghan population to the state, and in advocating for the vulnerable and excluded.

CSOs in Afghanistan face many challenges, including financial and capacity gaps and a public trust deficit, in their endeavors to play such a role effectively. The government, the international community, and civil society have been considering methods by which to support NGOs to address these challenges and realize their potential, dating back to the discussions in the Conference on Enabling Environment for Effective Private Sector Contribution to Development in Afghanistan held in June 2007. One of the outcomes of these considerations was the formation of a working group, with representation from international and national NGOs, key national NGO networks, and civil society professionals, to establish an organization that will enable NGOs to address these challenges. As a result, AICS was formed in 2015 in in pursuit for the following objectives:

- 1. To raise the credibility of the civil society sector by certifying local NGOs using locally defined and internationally recognized standards.
- 2. To systemize capacity building efforts by coordinating initiatives using measurable performance indicators.
- 3. To strengthen the role of civil society in Afghanistan's development through policy dialogue and active engagement with the government, donors and the broader development sector.
- 4. To provide a channel for resources for civil society by strengthening philanthropic and corporate social responsibility efforts.

It is expected that, in the future, AICS-certified NGOs will operate efficiently, transparently and effectively; will receive the support, resources, and technical assistance necessary to build their capacity; and will comply with international standards of management and governance. They will serve as standard bearers for a credible, creative and competent civil society sector in Afghanistan, and will enable the sector to play a critical role in national development.

Objective

The overall objective of this consultancy is to develop 5 year Strategic Plan to ensure that AICS fulfils its mandate.

AICS is recruiting a consultant to lead the strategic plan development process for the organization, working closely with the AICS Strategic Planning Committee (AICS, Aga Khan Foundation and an AICS board member) and the AICS Executive Director, This will be achieved through reviewing existing literature on civil society in Afghanistan, consultation with AICS stakeholders, and review of AICS' key strategic objectives. The consultant will use broad stakeholder consultations and analysis to develop the strategic plan.

Main Responsibilities:

Review the vision, mission, and strategic objectives of AICS and consult relevant literature on civil society and national strategies/policies and papers on Afghanistan -A consultative workshop within AICS

Assess and analyze AICS' internal and external environment and undertake a stakeholder mapping and analysis, synthesis the results and identify strategic opportunities

Conduct situation analysis, including identification of constraints and opportunities in line with AICS mandate

- Focus groups with AICS staff to discuss the constraints and opportunities

Conduct a consultative process, apply appropriate tools for analysis, identify focus areas and Threats, partner's future demand and develop strategic objectives and key result areas for the same.

Consultation with stakeholders and direct beneficiaries:

- 8 FGDs in 4 regions (4CDCs, 4 NGOs and Social Orgs)
- Individual meetings with key ministries (MoEcon, MoJ, MRRD, MoAIL, MoWA, MoPH and MoE)
- Individual meetings with key donors and INGOs

Review the institutional capacity, organizational set-up, financial and administrative systems against the AICS mandate and the identified strategic objectives and key result areas and Values.

Facilitate a process with the committee to develop key strategies for achieving the strategic objectives and key results. Relying on earlier analysis and stakeholder inputs.

Hold stakeholder meeting/s to validate the draft Strategic Plan

Two stakeholder consultation is required a) Before the facilitation process to ensure stakeholder views on priorities etc. are taken into consideration in developing the plan b) A more targeted process after the draft is prepared in order to validate the results.

Finalize strategic plan and submit to AICS

Qualifications Required

The consultant will require the following qualifications:

- At least a master's degree in a relevant field in the area of social science, business administration, organization development, public policy and or development studies.
- At least five years professional experience in strategic planning and management
- Prior working experience in civil society in Afghanistan
- High level written and oral communications skills in English and Dari/Pashtu
- Must be result-oriented, a team player, exhibiting high levels of enthusiasm, tact, diplomacy and integrity;
- Demonstrate excellent interpersonal and professional skills in interacting with AICS strategic committee members, stakeholders, including AICS Board, donors and partners
- Skills in facilitation of stakeholder engagements/workshops;
- Evidence of having undertaken similar assignments
- Experience in research, policy development, management and programming related
