**Delivery Location:**

With delivery to project location in Kabul

Please submit your quotation at GIZ Office indoor guards, and then they will put into the box, which was assigned for procurement of goods.

**Sample check:**

Supplier should provide the sample of all goods within 5 days if requested by GIZ Office.

**Lot:**

GIZ has the right to award the order lot wise, when it is indicated in the BoQ (Bill of Quantity).

**Evaluation Criteria:**

Order will be awarded to most economical offer, technical compliance with requested specification

**Bank Guarantee:**

If required, the winner company must provide bank guarantee for the total value of order.

**Withdrawal of tender process:**

GIZ reserves the right to waive off any formalities or reject any or all the tenders received without assigning any reason thereof.

No costs for submitting the tenders/quotations/drawing will be reimbursed by GIZ.

**Validity of Prices:**

Prices shall remain valid for a period of 30 days from submission of the quotation. GIZ shall have the right to request the bidders to extend the bid validity period if required.

Increase or decrease the quantities:

When awarding the contract, the Buyer reserves the right to increase or decrease the quantities per item by up to 20%, whereas the offered unit prices shall apply unchanged.

Banking details and business license:

- 1: Supplier should provide the banking details while submitting the quotations to GIZ Office.
- 2: Copy of business license should be attached with quotation

Language:

The language of the bid shall be English or Dari.

Prices:

The price should be included of (item price and delivery) while needed and VAT which is mentioned in the first is not applicable in Afghanistan.

Prices shall be quoted in Afghani. In order to compare bids in different currencies the exchange rate in between Afghani and US Dollar from the day of bid opening will be used.

Any arithmetical error by the tenderer in pricing the Bill of Quantities or in the additions or in carrying forward subtotals to the summary or to the Tender shall be corrected during the financial evaluation of the tenders. In such cases the Tender sum shall be adjusted accordingly, and the Tenderer shall be informed. It shall be assumed that the unit price rates entered in the Bill of Quantities are correct.

Payment:

Payment will be made within 15 working days after delivery and distribution, subject to appropriate deduction for incomplete and delayed deliveries, upon presentation of

- a commercial invoice (specifying quantities, unit and total price etc.)
- delivery notes issued by the authorized project representative.
- Payment will be made by bank transfer to the Supplier's bank account.

Tax Liabilities:

All tax liabilities, with regard to this tender / inquiry will be handled in accordance with the current tax laws of the Islamic Republic of Afghanistan (Article 72 and all other relevant provisions of the same law).

The suppliers should provide a copy of the organizations' (MoCI) Ministry of Commerce and industries licenses and TIN (Tax Identification Number) while submitting the quotations to GIZ
