Terms of Reference for Obtaining quote for Billboards Printing, Designing and installation of Banner

1. Organization background,

Organization background:

Marie Stopes International Afghanistan (MSIA) is a registered organization with the Government of Afghanistan. Our services change lives by enabling people to provide space between each pregnancy to have children by choice, not chance. MSIA focuses to reduce maternal mortality by providing high quality and sustainable Reproductive health (RH) services through a network of 30 static clinics, public and private sector support mechanism, social marketing and improving capacity of the health service providers in Afghanistan.

In addition, MSIA works jointly with a coalition of RH actors to enhance an enabling environment for sexual reproductive health rights to improve access to FP choices where couples can freely decide on the size of their family.

Purpose of the service:

The intention of expression of interest is to attract interested partners for advertisement of family planning messages through billboards in premium locations of Kabul city. The interested company must own legal certificates from the related offices of Afghanistan Gov. to apply for the advertisement through billboards tenure for the period covered by Service Level Agreement.

Scope of work and coverage:

- 1. Provide high quality graphic design with high resolution, MSI-A will provide necessary elements such as Aramish products so the service provider can capture high quality photos of product. Also, MSI-A is responsible to provide the photos of model for service provider.
- 2. Printing of flaxy of 300 grams
- 3. Installation of boards and provide locations of billboards at: Mazari square (Barchi), Morad Khani in front of Abolfazl mosque, Chahar rahi Sedarat, Sarak Baghe Bala, Chahar rahe Ansari within suitable rent per square meter.
- 4. Cost breakdown of graphic design of flaxy, printing, installation and rent of billboards in the quotation.

The service provider is expected to offer a quotation for 4 months' billboard advertisement. The quotation must be presented in Afghani currency with clear total amount.

- 5. The service provider will be responsible for tax payment and other legal formalities of mentioned locations to government of Afghanistan.
- 6. MSIA will not make any payment of to cause reprinting of the billboard due to spelling mistakes, printing size, colours, sunlight, natural disaster and other faults.

Service delivery:

Time is an essential part of the service delivery, If the company is not able to deliver the service by the specified date in the contracted. MSIA will have the right to change the service provider without further notice. In this circumstance, MSIA will not make any payment to the company. The payment will be made to the successful company only after the approval of MSIA responsible person.
