A. <u>Section 1: General Instructions to Offerors:</u>

1. Proposal Deadline and Protocol: RFQ must be received no later than Sunday 28 July, 2019 at 04:00 PM Kabul time. Hard copies must be submitted to NEI Kabul office. Please mention the RFQ/ RFP number in any response to this RFQ/ RFP. RFQ/ RFP received after the specified time and date will be considered late and will be considered only at the discretion of NEI.

- 2. Specifications: refer to Section C.
- 3. Quotations Requirement: Quotation must be submitted both in hard and soft copy. Soft copy will be sent to submissions@neifoundation.org and hard copy in sealed envelope will be submitted to NEI Kabul office at the address mentioned on letterhead of this RFQ.

Quotations in response to this RFQ must be priced on a fixed-price, all-inclusive basis, including delivery, 2% BRT and all other costs. Pricing must be presented in (\$ = USD). Offers must remain valid for not less than Forty Five (45) calendar days after the offer deadline. Offerors are requested to provide quotations on official letterhead or format; in the event this is not possible, offerors may complete the table in Section C

- 4. Delivery/ Job Completion: The job completion period for the items described in this RFQ is for Request for quotation for 8 MT soybeans and 8 MT soy flour mentioned above, each offeror is expected to provide an estimate (in calendar days) of the delivery/ job completion timeframe (after receipt of order). - 5. Taxes and VAT: Prices must be quoted on a lump-sum, all-inclusive basis. Any taxes (including BRT taxes) or fees are not to be added later. <u>The BRT tax must be included in the Grand Total Cost of the Proposal.</u> Offerors are required to submit their business license to support the 2% BRT tax. Pursuant to Article 72 in the Afghanistan Tax Law effective March 21, 2009, NEI is required to withhold "contractor" taxes from the gross amounts payable to all Afghan for-profit contractors. In accordance with this requirement, NEI withholds two percent (2%) tax from all gross invoices to Afghan subcontractors under this agreement with active business registration license.

Evaluation and Award: The award will be made to a responsible offeror whose offer follows the RFQ instructions, meets the eligibility requirements, and meets or exceeds the minimum required technical specifications, and is judged to be the best value based on a lowest-price, technically-acceptable basis. The relative importance of each individual criterion is indicated by the number of points below:

 - 2) **Technical Specifications– 30 points:** The overall technical capability presented in the offer.
