Offers must be received by e-mail, no later than August 26, 2019 by 15:00 hours (Local Time).

An electronic submission must be sent to ACEP.Procurement@counterpart.org no later than the due date and time listed in the timeline of the RFQ. The subject line of the quotation email must be "CPI-ACEP-2019-1564, Broadcasting of the Public Service Announcements (PSA), for Peace.". Quotations submitted by email must be limited to a maximum of 4 MB, virus-free email transmissions. They must be free from any form of virus or corrupted contents, or the quotations shall be rejected. It shall remain offer's responsibility to ensure that the quotation will reach the address above on or before the deadline.

Quotations received after the specified time and date is considered late, and will only be included in the evaluation process at the discretion of Counterpart.

1. INTRODUCTION/BACKGROUND

Counterpart International (Counterpart) in Afghanistan is implementing the Afghan Civic Education Program (ACEP) program funded by USAID under Cooperative Agreement No AID-306-A-14-00001. The ACEP Program aims to increase the role and viability of civil society in Afghanistan by providing capacity building, training and small grants to civil society organizations that show potential to be sustainable and effective organizations.



Offerors should put forward their qualifications and price quote to support COUNTERPART in Broadcasting services. As a result of this RFQ, COUNTERPART anticipates issuing a Firm Fixed Price Purchase Order.

1. SCOPE OF WORK

COUNTERPART seeks a Broadcasting Service Company or firm to provide Broadcasting Services of Public Service Announcements (PSA) for Peace for civic education campaign throughout the country, all 34 provinces simultaneously in both peak in Golden hours (300 minutes) and non-peak/Golden hours (100 minutes). The duration of broadcasting is outlined in Section 3 below, *Specification and Technical Requirements*.

2. REQUIRED QUALIFICATIONS/ TECHNICAL SPECIFICATIONS

Offerors should show qualifications in the following areas:

- I. Ability to furnish required services and to meet the requirements of the RFQ.
- II. Experience in similar Broadcasting services, sufficient references, and customer satisfaction.
- III. Quality of Broadcasting services offered, (determined by a sample of similar work to be provided with the quotation).

3. ANTICIPATED PERIOD OF PERFORMANCE

The anticipated period of performance for this scope is approximately 3 months.

4. PRICE OFFER

Quotations in response to this RFQ must be priced on a fixed-price, all-inclusive basis, including delivery and all other costs such as tax. Pricing must be presented in Afghani (AFN). Offers must remain valid for not less than 90 calendar days after the offer deadline. Offerors are requested to provide quotations on official letterhead or format.

In addition, offerors responding to this RFQ are requested to submit the following:

- Organizations responding to this RFQ are requested to submit a copy of their official registration or business license.
- Individuals responding to this RFQ are requested to submit a copy of their identification card.

EVALUATION PROCEDURES AND CRITERIA

The award will be made to a responsible offeror whose offer follows the RFQ instructions, meets the eligibility requirements, and meets or exceeds the minimum required technical specifications, and is judged to be the best value based on a lowest-price, technically-acceptable basis.



Please note that if there are significant deficiencies regarding responsiveness to the requirements of this RFQ, an offer may be deemed "non-responsive" and thereby disqualified from consideration. Counterpart reserves the right to waive immaterial deficiencies at its discretion.

Best-offer quotations are requested. It is anticipated that award will be made solely on the basis of these original quotations. However, Counterpart reserves the right to conduct any of the following:

- Counterpart may conduct negotiations with and/or request clarifications from any offeror prior to award.
- While preference will be given to offerors who can address the full technical requirements of this RFQ, Counterpart may issue a partial award or split the award among various suppliers, if in the best interest of the ACEP Project.
- Counterpart may cancel this RFQ at any time.

Please note that in submitting a response to this RFQ, the offeror understands that USAID is not a party to this solicitation and the offeror agrees that any protest hereunder must be presented—in writing with full explanations—to the ACEP Project for consideration, as USAID will not consider protests regarding procurements carried out by implementing partners. Counterpart, at its sole discretion, will make a final decision on the protest for this procurement.

INSTRUCTIONS ON SUBMISSION OF OFFERS:

You are requested to submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation. Offerors must provide the following information:

- a. The solicitation/RFQ number;
- b. The name, addresses (street, email, other), and telephone number of the offeror;
- c. Brief qualifications of the consultant, organization or firm and its capacity to fulfill the technical specifications including corporate capabilities;
- d. Proof of eligibility to work and or registration in the Islamic Republic of Afghanistan.
- e. Past performance information: include recent and relevant contacts for the same or similar items and other references (including points of contact with telephone numbers and email addresses);
- f. Price quote in Afghani
- g. "Remit to" address, if different than mailing address.

It is contemplated one firm fixed price vendor contract will be awarded to the responsive Offeror whose offer meets or exceeds the minimum required technical specifications, and is judged to be the best value based on a lowest-price, technically-acceptable basis. COUNTERPART reserves the right to make an award based on initial submission. COUNTERPART reserves the right to make no award if it is determined that the offers submitted do not satisfy the needs of the organization. Offers shall be submitted via email



and received no later than on the closing date and time. Offers received after the specified time and date will be considered late and will be considered only at the discretion of COUNTERPART. All written proposals submitted must be valid for a period of not less than Ninety (90) calendar days from the stated closing date.

6. QUESTIONS AND REQUESTS FOR CLARIFICATIONS

Questions regarding the technical or administrative requirements of this RFQ may be submitted no later than **15:00** hours on August **21, 2019** by email to <u>ACEP.Procurement@counterpart.org</u>. Questions must be submitted in writing; phone calls will not be accepted. Questions and requests for clarification—and the responses thereto—that COUNTERPART believes may be of interest to other offerors will be posted on www.acbar.org website as an amendment to the RFQ.

Only the written answers posted by COUNTERPART will be considered official and carry weight in the RFQ process and subsequent evaluation. Any verbal information received from employees of COUNTERPART or any other entity should not be considered as an official response to any questions regarding this RFQ.

7. NOTIFICATION OF SELECTION

Prior to the expiration period of proposal validity (ninety (90) days), COUNTERPART will notify the offeror who submitted the highest scoring proposal in writing by Email. Clarifications and revision of minor errors and omissions may be requested. Upon completion of either, offeror may be required to submit a revised quote.
