- Translated version should be submitted in Ms. Word format
- Translations will be only accepted if it meets the standard and quality by the end user of the document. Payment will not be released until quality translation is done.
- Incase technical errors, poor quality or inconsistency with document owner's standards and criteria, consult should revised the document up to two times; revisions require beyond these, will bring a penalty of five percent of the total value of the contract.
- To ensure quality translation, consultant should review translation for quality prior submission, seek feedback and response to recommendations provided.

Quality Assurance:

Translated document should be error free and will be checked as per the following criteria.

- Meaning Errors: Examples include, missing words, addition of extra words, using
 of wrong terminology, style compliance error, fluency error, literal translation
 etc.
- Grammar/ Form Errors: Examples include spelling, punctuation and syntax errors

The Offerors' quotation shall be evaluated to determine overall technical capability to effectively implement the project. The sub-factors used to determine this will be

 to meet or exceed requirements. Technical proposal shall demonstrate maximum
 translation capability per day and tools and methodologies used in translation,
 quality assurance, usage of appropriate terminologies to ensure that the
 consultant best fits the project needs.
- Sample: At least one relevant sample work shall be provided
- CVs: CV of the staff for the translation.
