SCOPE OF WORK For PROVISION AND INSTALLATION OF SIGNPOSTS AND DOORWAYS

The firm fixed price purchase order shall cover the provision and installation of addressing materials in the specified district of the municipality. The works to be undertaken are as follows:

- Provision of doorway number plates and street sign posts including, painting, printing of texts, logo, welding and numbering
- Installation of doorway numbers on facades or appropriate locations of buildings and shops
- Installation of signposts at the corner of certain streets

Types of Materials to be installed

Street sign shall be made of 2mm thick steel sheet measuring 500mm X 300mm. Two (2) pieces of street signs shall be affixed to each street sign post of 2.5" diameter GI pipe with thickness of 2.9mm and length/height of 2.5 meters. For additional specifications, refer to street sign post drawings. The bottom of each pole has an anchor or root of 12mm diameter rebar to prevent the pole from wavering in its concrete pedestal. The doorway number will measure 250mm by 170mm with thickness of 4mm Alocoband with aluminum sheet on both faces and blue factory paint on it, and shall be fixed to the facades by 1.5" or 2" screw.

SHAHAR will provide the following information;

- City address map (1:2000), including, among other details, the names and numbering to be used for street sign posts;
- Signage map (1:2000), showing the locations street sign post to be installed;
- List of doorway numbers and streets confirming the information printed on the mentioned address map.

Installation Works

Before any installation work begins, the vendor should provide SHAHAR with an implementation schedule. This schedule will include details about the timing of the production of street signs and doorway numbers and suggested timing for SHAHAR to conduct quality inspection, installation team, its itinerary, and equipment to be used. The vendor may take this opportunity to make suggestions for improvements to the work of providing and installing addressing materials. The vendor is likewise required to inform SHAHAR of the specific location its production facilities for the purpose of the aforementioned quality inspection. The production of addressing materials can only proceed upon agreement by SHAHAR on the implementation schedule.

The vendor will provide mounting hardware (assembly jigs, screws, nuts, bolts, doorway number plates, signs and signposts). To complete the installation work, the vendor shall have available tools (rechargeable drills, screwdrivers, wrench sets and small masonry materials) as well as the logistics required to operate the tools (batteries and double-sided ladders) and to transport the installation teams throughout the area (vehicles).

Installation of doorway numbers will adhere to the following guidelines:

- Doorway numbers will be placed on the walls of buildings or of permanent facades preferably 2-2.5m above the ground and at least 30cm from the corner of the wall.
- The doorway numbers will preferably be placed above doors and on permanent mountings. If this is not possible, they will be placed to the right or left of the doorway, 2m above the ground and on the side opposite to the hinge side, so that the signs are not obscured in any way.

Bi-directional signposts will be installed and street signs affixed as follows:

- The signposts will be placed in the ground according to indications on the signage map. They shall not impede pedestrian or car traffic.
- The signposts shall have a base made of shuttered concrete with strength of 200 kg/cm2, with a 30cm x 30cm cross section. The base shall be about 60cm deep, including 10cm above the natural ground and at least 50cm buried. The bottoms of the holes for the bases shall be cleared of all debris, organic materials, and any other substances that could interfere with the quality of the work.
- The two street signs will be fixed to the GI post by GI clamp (3mm thick, 1.5" wide) with 2x10mm nat-bolt
- Two 200mm long deformed bar (

 12mm) shall be welded to the bottom of the post as root to keep the post fixed in the concrete.
- The sign plate only should be painted with 2 antirust coats and 2 coats of blue oil paint or any other recommended paint, including the welding surface before writing the street name, code, logo and number according to the sample provided in below annexes.

Addressing Materials Installation Teams

The vendor shall be required to take all necessary measures to provide a sufficient number of installation teams to complete all work within the contractually required deadline. The vendor is also responsible for assigning at least one senior technician (civil engineer, urban planner, or topographer) to remain on the job site at all times.

Submittals:

The vendor is responsible to provide the samples of the signposts and doorway number plates and get the SHAHAR approval before proceeding for casting the signposts or the doorway plates.

Time Frame

The period for completion of work is set at 135 Calendar days from the date of signature of the contract.

Quantities

For Jalalabad Municipality Nahya (2), the following quantities will be required:

- Street sign posts (with two sign plates each): 237
- Doorway number plates: 13592

Cost of Services

The vendor is assumed to have full knowledge of the project's limitations and all local conditions that may affect the performance of the work, including but not limited to:

- Travel conditions and access to worksites
- Difficulties of any kind related to storage, supply, and installation

The prices proposed must include all charges required for the performance of all work, including: labor costs, travel costs, costs of supplying materials, equipment, and tools, costs incurred due to damages caused to a third party, costs related to poor handling of mountings, street sign maintenance costs during the guarantee period, costs related to limitations and unexpected and unforeseen occurrences.

Generally speaking, all constraints and limitations that the contractor experiences in the course of successfully performing the work are covered under this contract, whether or not they are specifically listed herein. The contractor is assumed to have full knowledge of all such circumstances, having personally completed a field assessment before presenting his bid.

Inspection and Monitoring

The municipality or its authorized agent and SHAHAR inspection person reserves the right to perform field inspections during and at the work. The contractor shall take all necessary measures to ensure that these inspections are carried out under the most favorable conditions. If inspections reveal mistakes made in the work, the contractor will be responsible for correcting these mistakes to the satisfaction of the SHAHAR technical team as well as the municipality or its agent. In addition the contractor is responsible to have a journal book for the project in order to record all the given instruction during the implementation of the project by SHAHAR or Municipality Authorized Representatives

Final Certificate of Completion

Final Inspection will be made in the presence of the contractor and the manager of the addressing unit representing the municipality. Contract-related inspections will specifically cover: quantity of addressing materials installed, quality of installation, and compliance of installation scope and technical drawings.

The vendor should have:

- Worked with municipalities in addressing systems or other relevant experience in urban development
- Completed construction projects
- Have qualified staff to complete the project
- Completed social and community-based surveys

Deliverables:

SHAHAR will do the PO payments as per following progress percentages in two installments:

- 1st installment: 50 % of the total payment (when the progress percentage is at least 60%)
- 2nd installment: 50 % of the total payment (when the progress percentage is 100%)

- 1. <u>Federal Excluded Parties List</u> The Bidder Select is not presently debarred, suspended, or determined ineligible for an award of a contract by any Federal agency.

- 4. <u>Subcontracting Requirements (January 2012)</u> (a) Applicability: This section limits the number of tiers of sub-contracts to one tiers below the Vendor. The Vendor must not allow lower-tier subcontracts without the express written approval of DAI. Should exceptional circumstances warrant subcontracting below one tier, the Vendor shall promptly request approval in writing from DAI. The Vendor shall include this clause in all subcontracts, and shall require subcontractors to include this clause in all lower-tier subcontracts. The Vendor shall be responsible for compliance with this clause by all subcontracts and lower-tier subcontractors.
- <u>Combating Trafficking of Persons (Feb 2009)</u> The Contractor may not traffic in persons (as defined in the Protocol to Prevent, Suppress, and Punish Trafficking of persons, especially Women and Children, supplementing the UN Convention against Transnational Organized Crime), procure commercial sex, and use forced labor during the period of this award.
- (a) Definitions. As used in this clause-

"Coercion" means—(1) Threats of serious harm to or physical restraint against any person; (2) Any scheme, plan, or pattern intended to cause a person to believe that failure to perform an act would result in serious harm to or physical restraint against any person; or (3) The abuse or threatened abuse of the legal process.

"Commercial sex act" means any sex act on account of which anything of value is given to or received by any person. "Debt bondage" means the status or condition of a debtor arising from a pledge by the debtor of his or her personal services or of those of a person under his or her control as a security for debt, if the value of those services as reasonably assessed is not applied toward the liquidation of the debt or the length and nature of those services are not respectively limited and defined.

"Employee" means an employee of the Contractor directly engaged in the performance of work under the contract who has other than a minimal impact or involvement in contract performance.

"Forced Labor" means knowingly providing or obtaining the labor or services of a person—(1) By threats of serious harm to, or physical restraint against, that person or another person; (2) By means of any scheme, plan, or pattern intended to cause the person to believe that, if the person did not perform such labor or services, that person or another person would suffer serious harm or physical restraint; or (3) By means of the abuse or threatened abuse of law or the legal process.

"Involuntary servitude" includes a condition of servitude induced by means of— (1) Any scheme, plan, or pattern intended to cause a person to believe that, if the person did not enter into or continue in such conditions, that person or another person would suffer serious harm or physical restraint; or (2) The abuse or threatened abuse of the legal process.

"Severe forms of trafficking in persons" means— (1) Sex trafficking in which a commercial sex act is induced by force, fraud, or coercion, or in which the person induced to perform such act has not attained 18 years of age; or (2) The recruitment, harboring, transportation, provision, or obtaining of a person for labor or services, through the use of force, fraud, or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage, or slavery.

"Sex trafficking" means the recruitment, harboring, transportation, provision, or obtaining of a person for the purpose of a commercial sex act.

(b) *Policy*. The United States Government has adopted a zero tolerance policy regarding trafficking in persons. Contractors and contractor employees shall not— (1) Engage in severe forms of trafficking in persons during the period of performance of the contract; (2) Procure commercial sex acts during the period of performance of the contract; or (3) Use forced labor in the performance of the contract.

(c) Contractor requirements. The Contractor shall-

(1) Notify its employees of-

(i) The United States Government's zero tolerance policy described in paragraph (b) of this clause; and

(d) Notification. The Contractor shall inform the Contracting Officer immediately of-

(1) Any information it receives from any source (including host country law enforcement) that alleges a Contractor employee, subcontractor, or subcontractor employee has engaged in conduct that violates this policy; and (2) Any actions taken against Contractor employees, subcontractors, or subcontractor employees pursuant to this clause.

(e) *Remedies.* In addition to other remedies available to the Government, the Contractor's failure to comply with the requirements of paragraphs (c), (d), or (f) of this clause may result in—

(1) Requiring the Contractor to remove a Contractor employee or employees from the performance of the contract; (2) Requiring the Contractor to terminate a subcontract; (3) Suspension of contract payments; (4) Loss of award fee, consistent with the award fee plan, for the performance period in which the Government determined Contractor non-compliance; (5) Termination of the contract for default or cause, in accordance with the termination clause of this contract; or (6) Suspension or debarment.

(f) *Subcontracts.* The Contractor shall include the substance of this clause, including this paragraph (f), in all subcontracts.

(g) *Mitigating Factor*. The Contracting Officer may consider whether the Contractor had a Trafficking in Persons awareness program at the time of the violation as a mitigating factor when determining remedies. - 6. <u>Certification and Disclosure Regarding Payment to Influence Certain Federal Transactions</u> The Bidder certifies that it currently is and will remain in compliance with FAR 52.203-11, <u>Certification and Disclosure Regarding Payment to Influence Certain Federal Transactions</u>.
- 7. <u>Organizational Conflict of Interest</u> The Bidder certifies that will comply FAR Part 9.5, Organizational Conflict of Interest. The Bidder certifies that is not aware of any information bearing on the existence of any

potential organizational conflict of interest. The Bidder further certifies that if the Bidder becomes aware of information bearing on whether a potential conflict may exist, that Bidder shall immediately provide DAII with a disclosure statement describing this information.

- Business Size and Classification(s) The Bidder certifies that is has accurately and completely identified its business size and classification(s) herein in accordance with the definitions and requirements set forth in FAR Part 19, Small Business Programs.
- 9. <u>Prohibition of Segregated Facilities</u> The Bidder certifies that it is compliant with FAR 52.222-21, Prohibition of Segregated Facilities.
- 10. <u>Equal Opportunity</u> The Bidder certifies that it does not discriminate against any employee or applicant for employment because of age, sex, religion, handicap, race, creed, color or national origin.
- 11. Labor Laws The Bidder certifies that it is in compliance with all labor laws..

(1) The Vendor, to the best of its current knowledge, did not provide, within the previous ten years, and will take all reasonable steps to ensure that it does not and will not knowingly provide, material support or resources to any individual or entity that commits, attempts to commit, advocates, facilitates, or participates in terrorism acts, or has committed, attempted to commit, facilitated, or participated in terrorist acts, as that term is defined in paragraph 3.

(2) The following steps may enable the Vendor to comply with its obligations under paragraph (1):

a. Before providing any material support or resources to an individual or entity, the Vendorr will verify that the individual or entity does not (i) appear on the master list of Specially Designated nationals and Blocked Persons, which list is maintained by the U.S. Treasury's Office of Foreign Assets Control (OFAC) and is available online at OFAC's website: http://www.treas.gov/offices/eotffc/ofac/sdn/t11sdn.pdf, or (ii) is not included in any supplementary information concerning prohibited individuals or entities that may be provided by USAID to DAI.

b. (3) For the purpose of this Certification.

a. "Material support and resources" means currency or monetary instruments or financial securities, financial services, lodging, training, expert advice or assistance, safehouses, false documentation or identification, communications equipment, facilities, weapons, lethal substances, explosives, personnel, transportation, and other physical assets, except medicine or religious materials.

b. "Terrorist act" means -

(i) an act prohibited pursuant to one of the 12 United nations Conventions and Protocols related to terrorism (see UN terrorism conventions Internet site: http://untreaty.un.org/English /Terrorism.asp); or

(ii) an act of premeditated, politically motivated violence perpetrated against noncombatant targets by subnational groups or clandestine agents; or

(iii) any other person not taking an active part in hostilities in situations of armed conflict, when the purpose of such act, by its nature or context, is to intimidate a population, or to compel a government or an international organization to do or to abstain from doing any act.

c. "Entity" means a partnership, association, corporation, or other organization, group or subgroups.

d. Reference in this Certification to the provision of material support and resources shall not be deemed to include the furnishing of USAID funds or USAID-financed commodities to the unlimited beneficiaries of USAID assistance, such as recipients of food, medical care, micro-enterprise loans, shelter, etc., unless the Vendor has reason to believe that one or more of these beneficiaries commits, attempts to commit, advocates, facilitates, or participates in terrorist acts, or has committed, attempted to commit, facilitated or participated in terrorist acts.

(b) By accepting or start performing this Purchase Order, the Vendor acknowledges that it has a continuing obligation and shall notify DAI within 72 hours in writing if it has intentionally or unintentionally taken any actions that have the result and effect of being inconsistent with the certification in subsection (a).

(c) The certification in paragraph (a) of this clause and the requirement to update DAI as to a change in status as set forth in paragraph (b) are representations upon which reliance was placed when making the award. If it is later determined that the Vendor knowingly rendered an erroneous certification, or did not notify DAI in writing of a change in such certification, in addition to other remedies available to the U.S. Government and DAI, DAI may terminate this subaward for default. DAI may also cease payments due to the Vendor even if goods and services have been provided.

16. Restrictions on Certain Foreign Purchases (June 2008) -

17. Authorized Geographic Code

"Involuntary servitude" includes a condition of servitude induced by means of-

(1) Any scheme, plan, or pattern intended to cause a person to believe that, if the person did not enter into or continue in such conditions, that person or another person would suffer serious harm or physical restraint; or (2) The abuse or threatened abuse of the legal process. "Severe forms of trafficking in persons" means—

(1) Sex trafficking in which a commercial sex act is induced by force, fraud, or coercion, or in which the person induced to perform such act has not attained 18 years of age; or (2) The recruitment, harboring, transportation, provision, or obtaining of a person for labor or services, through the use of force, fraud, or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage, or slavery.

"Sex trafficking" means the recruitment, harboring, transportation, provision, or obtaining of a person for the purpose of a commercial sex act.

(b) *Policy.* The United States Government has adopted a zero tolerance policy regarding trafficking in persons. Contractors and contractor employees shall not—
