Enclosed is a request for quotation of Internet services for ADF Kabul Office. ADF invites firms to submit their bid offers for subject RFQ.

**I. Type of Subcontract** – An award resulting from this RFQ will be a Blanket Purchase Agreement (BPA) with Ceiling amount for 12 months.

**II. Submission of Questions:**

All quotations are due in Kabul on **08 December, 2019** by no later than 1600 hours local Afghanistan time. Quotations received at the office designated below after 1600 hours (4:00 p.m.) will not be considered. Bidder should submit **one** complete hardcopy of the offer **Before Due Date 08 December, 2019**. Submissions by email or fax will not be accepted. Bidder's proposals should not contain any unnecessary promotional material or elaborate presentation formats (black and white is preferred). Bidder's standard technical specifications and product literature are preferred. Bidder should confirm by phone to ADF Procurement department for ADF email acknowledgment.

**IV. Background:** The Agricultural Development Fund (ADF) is a standalone government owned financial institution with the fundamental purpose of making credit available to the agriculture sector. The target clientele of the ADF includes small commercial farmers, as well as agribusiness engaged in distribution of agricultural inputs, producers of high-value crops, processors and exporters of agricultural products. ADF functions as a wholesale lender, channeling credit through financial and non-financial institutions.

Agricultural credit provided by the ADF is enabling farmers and other players in the agriculture sector to put in practice modern production, processing and market development practices acquired in the last decade.

ADF reserves the right to award a purchase order without discussion and/or negotiation; however, ADF also reserves the right to conduct discussions and/or negotiations, which among other things may require an Offeror(s) to revise its quote (technical and/or price. Issuance of this RFQ in no way obligates ADF to award a purchase order, nor does it commit ADF to pay any costs incurred by the Offeror in preparing and submitting the quote.

**VII. Composition of Quote** – Offerors shall submit his quote for items detailed in Appendix B Detailed Cost Breakdown/Bill of Quantities. The quote will consist of Appendix A through E (see above).

**SECTION 1 – QUOTATION INSTRUCTIONS / ADDITIONAL INFORMATION**

The Offeror shall submit its best price offer/quotation as per the following requirements:

1. Quotation Cover Letter signed by a person authorized to sign on behalf of the Offeror. Use the template in Appendix A.
2. All Prices shall be quoted in Afghan Local Currency (Afghanis) only, Offers in other currencies will not be considered.
3. Offeror shall submit quotes in prescribed format of Appendix B.
4. In case of price discrepancy between unit price and SUBTOTAL price, the unit price shall prevail.
5. The rates quoted shall be for complete service inclusive of all taxes all charges for service contingent to the work.
6. ADF has the rights to increase or decrease the goods and services mentioned in this RFQ
7. ADF Payment term: Net 30 days.
8. Bid validity: Net 30 days from date of submission
9. ADF will not award a subcontract or purchase order to an organization without AISA/Ministry of Commerce Business license. The AISA/Ministry of Commerce Business License must be attached to the quotation.

**SECTION 2 – DESCRIPTION OF GOODS OR SERVICES REQUESTED**

**SECTION 3 – SPECIAL PROVISIONS**

The below provisions will be incorporated into any purchase order issued by ADF.

**3.1. Government Withholding Tax**

Pursuant to Article 72 in the Afghanistan Tax Law effective March 21, 2009, ADF is required to withhold "contractor" taxes from the gross amounts payable to all Afghan for-profit subcontractors/vendors. In accordance with this requirement, if the total amount for one year is more than AFN 500,000 .ADF shall withhold two percent (2%) tax from all gross invoices to Afghan subcontractors/vendors under this Agreement with active AISA or Ministry of Commerce license. For subcontractors/vendors without active AISA or Ministry of Commerce license, ADF shall withhold seven percent (7%) "Contractor" taxes per current Afghanistan Tax Law.

Before the signing of this Agreement, the subcontractor/vendor will provide a copy of the organization's AISA or Ministry of Commerce license and TIN (Tax Identification Number). Amounts deducted from the invoices will be forwarded to the Ministry of Finance (MOF) Tax Division credited to the firm's TIN. Records of payments to the MOF shall be maintained on file with ADF.

**3.2 Penalty Charges**

If the Vendor fails to supply the specified Goods/Services within the date stipulated, ADF shall, without prejudice to its other remedies under the Purchase Order/Contract price, as liquidated damages, deduct a sum equivalent to five percent (5%) of the delivered price of the delayed Goods/Services for each week of the delay until actual delivery, up to a maximum deduction of Ten Percent (10%) of the Purchase Order/Contract/Contract value.

**SECTION 4 - EVALUATION CRITERIA**

All quotations received in response to this solicitation will be evaluated and scored by evaluation sub factors. The Subcontract/Purchase Order shall be awarded on a tradeoff bases. The following sub factors shall be used to evaluate offers: ADF will award subcontract(s) resulting from this solicitation to the responsive Bidder whose proposal will be most advantageous to ADF, price and other factors considered. Therefore, the Bidder's initial offer should contain the best terms from a price and technical standpoint. If determined to be necessary, ADF reserves the right to conduct discussions with the Bidder. ADF may reject any or all offers if such action is in the interest of ADF or the public; accept other than the lowest offer; and waive informalities and minor irregularities in offers received.

**The vendors will be evaluated according to the following criteria:**

- Price (80%)
- Past performance (10%)
- Responsiveness (10%)

**Network performance specification**

Packet loss should not be greater than 5% measured as follows:

- ICMP echo ping packets will be sent to a www public site such as [www.google.com](http://www.google.com) at a rate of 20 or more each 5 minutes. For example:
- Ping testing will normally be conducted during network loads of 50-80% if possible.
- The response time to a public site should not exceed 200 ms
- A loss, or a response time > 200 ms, of more than 5% (>1 out of 20) for any 5 minute interval will cause that 5 minute period to be counted as unacceptable. If the number of unacceptable 5 minute periods exceeds 5% of the number of periods in a > calendar month is unacceptable. The payment for any month with an unacceptably high rate of packet loss will be reduced by a percentage equal to the percentage of packet loss in > excess of 5%.
- Ping testing will be conducted 24x7 during network loads of 80% or less..

Telephone support shall be available 24x7.

**Installation Requirements**

- Ensure the full protection of the equipment and cables from any external damages
- Microwave / WiMAX or other communication equipment must be attached to a sturdy mast, firmly attached to the building and properly grounded
- The cable from the Antenna should be STP cable
- Internet service backbone should only be Fiber, not Satellite
- Final report of installation including photographs upon completion of installation
- The designated Office Manager or a designated ADF staff member must accept the initial installation in writing.

- Detailed list of equipment and specifications, including brand names, for the recommended Microwave / WiMAX or other equipment
- A detailed list of delivery times and date of completion for this installation
- Schedule to procure, ship, and insure Microwave / WiMAX or other and network equipment from point of origin

**Tasks**

The contractor shall:

1. Meet and work with ADF staff and others as required;
2. Provide specifications and brand names for the recommended Microwave / WiMAX equipment a schedule to install, and insure Microwave / WiMAX from point of origin to the ADF Office in Kabul.
3. Cable, install and satisfactorily test Microwave / WiMAX equipment;
4. Ensure the full protection of the equipment and cables from any external damages;
5. Provide one year warranty and maintenance of Microwave / WiMAX hardware and software;
6. Guarantee up time of greater than 97% for Microwave / WiMAX services;

1. **All Bandwidth should be dedicated not share.**
2. The Payment will be made at the end of each month based on invoice submitted by the company.
3. The amount will be transferred to the company account not to individual account.
4. ADF reserves the right to cancel or terminate the BPA if the company is not able to provide the satisfactory services.
5. 2% of tax will be deducted from the total amount of invoice if the company is registered and have the valid registration documents from Afghanistan Government, if the company is not registered then 7% of tax will be deducted based on Afghanistan Taxation Law.
6. ADF reserves the right to issue multiple contracts under this RFQ or to issue no contract if the responses are not adequate.
