The Islamic Republic of Afghanistan, Kabul Municipality has received a ["Grant" from the Afghanistan Reconstruction Trust Fund (ARTF) financing from the World Bank toward the cost of Kabul Municipal Development Program and intends to apply part of the proceeds toward payments under the contract for Upgrading Infrastructure of Naw Abad of Reshkhor (Lot-2) Gozar, Dis. 7, RFB No: KMDP/W-108/U

- Achieved in any one year during the last five years a minimum annual financial turnover in civil (a) engineering construction work of AFN 80,000,000.
- Completed substantially at least one similar contract within the last five years with a minimum (b) value of *AFN 54,000,000*.

A Project Manager with five years' experience in works of an equivalent nature and volume, including no less than three years as Manager; Road and Drainage Engineer and (QA-QC) Manager all with three years' experience in works of a similar nature and complexity..
- (e) Bidder must demonstrate access to liquid assets or credit facilities by submitting the Banker's certificate for an amount of *AFN 17,000,000*.
- (f) Bidder shall not have during the last 5 years (i) history of non-performance of a contract or (ii) a consistent history of litigation or arbitration awards.
- 4. Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" July 01, 2016 ("Procurement Regulations"), and is open to all Bidders as defined in the Procurement Regulations.

- 7. Bids must be delivered to the address below on or before 10:00 AM local time on the February 19, 2020. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below.
