The offers must reach to DACAAR Main Office Logistics Unit located in (Street No. 12, Qala-e-Fathullah, Wazirabad Paikob Kabul Province) till 4:00pm February 29, 2020.

The bid opening session will be held on March 01, 2020 at 10:30am in DACAAR Main Office, Kabul Province and the bid winner will be notified shortly after bid opening session.

Please include the followings in your offer:

- Time for the installation of Internet System.
- One-week demo period for bandwidth check plus user and password for the devices to check the bandwidth traffic mentioned in the contract.
- Provision of the description for trouble-shooting, service & support.
- Price for installation plus monthly charges for provision of Internet System.
- Warranties for all equipment's/hardware and installation must be mentioned in your offer, if the device is not in lease or free till end of contract.
- Guarantee for providing speeds stability and connection must be mentioned in your offer.
- A read only user and password in main device for DACAAR ICT to check the live bandwidth speed in internet device.
- A copy of the certificate or registration letter of the ISP from the Ministry of Telecommunication (ATRA) and (MoTC) must be provided.
- Price must include Government Tax (2% for the registered company and 7% for the unregistered company and expired license holders).
- Attach a proven document of your previous work experience.
- Prices must be in USD.

Terms & Condition for Contract:

- Only the quotations that meet the exact specifications will be considered.
- Technical Inspection/Evaluation will be done by DACAAR Technical Unit before and after installation.
- Payment will be made through bank transfer after technical confirmation and inspection by DACAAR at the end of each month.
- The contract duration is for one year and it will be extended based on mutual agreement after a market survey.
- The ISP must guarantee their service originality, in case of any discrepancy, DACAAR has the right to terminate the contract without any notice.
- If the ISP wants to bring any changes in their Hardware during the services, it has to be done formally, if DACAAR agrees.
- 5 real live IP's for each connection.
- The ISP has to share two focal points official phone numbers and email addresses for daily support.

- The internet connectivity/ Bandwidth should be dedicated and remain the same 24/7 connected with support and service.
- The bandwidth should always be stable and shows the exact bandwidth after installation and the rest of service 24/7.
- Payment will be done against monthly bills through DACAAR Main Office.
- DACAAR will track the interruption intervals and it will be deducted from the payment and if it occurs continuously, DACAAR has the right to terminate the contract immediately.
