

## Request for Quotations (RFQ) No. 786

Issuance Date: March 31, 2020 Closing Date: April 7, 2020

Jhpiego is seeking for qualified vendors to obtain quotations for procurement of <u>Genuine Parts</u> for its vehicles in Kabul. Vendors are requested to submit their quotations along with the supporting documentation (copy of valid business license, official bank account detail and a copy of TIN letter) by no later than April 7, 2020.

Vendors are requested to see the list of vehicles (Annex B) in the last page of this RFQ and provide a complete quotation considering each vehicle.

Jhpiego will issue blanket purchase order and will order parts based on its need.

Annex A: Vendor registration form must be filled otherwise the applicant will be disqualified Annex B: Spare parts details (Enclose with this RFQ)

#### **Applicant Eligibility:**

- The potential vendors must be registered with the government of Afghanistan and have a valid AISA or Business license. A Vendor's current, valid AISA or Ministry of Commerce Business License must be attached with their quotation.
- The potential vendors should provide an Official Bank Account with the same name as it is stated in Vendor's AISA or business license.
- The potential vendors should accept tax withholding based in Afghanistan Tax Law.
- All the cost should be stated in Local currency (AFN).

#### Evaluation will be based on lowest price offered.

### **Section 1. Instructions to Offerors:**

- 1. Offer Deadline and Protocol: Vendors are requested to submit their complete quotations in an envelope (signed and stamped with RFQ on the envelope) and deliver no later than Apr 8, 2020, 3:00 p.m. via email to Af.procurement@jhpiego.org
- 2. Questions: Should be directed to the above email address by no later than April 5, 2020.

**Note**: Vendors are requested to submit their complete quotations outlining the **ORIGINAL** spare parts prices for the vehicles in Annex B.

**Supporting Documentation:** Please attach a copy of valid business license, official bank account detail and a copy of TIN letter. Quotations without these supporting documents will not be considered and will be disqualified.

Offers received after the specified time and date will be considered late and will not be evaluated.

<u>3.</u> <u>Quotations</u>: Quotations in response to this RFQ must be priced on a fixed-price, all-inclusive basis, including delivery and all other costs. Pricing must be presented in AFN. Offers must remain valid for not less than three months after the offer deadline.



- 4. Taxes and VAT: Prices must be quoted as per a unit, all-inclusive basis. Any taxes (including BRT taxes) or fees are not to be added later. The BRT tax must be included in the Grand Total Cost of the Proposal. Offerors are required to submit their business license to support the 2% BRT tax.
- <u>5.</u> Pursuant to Article 72 in the Afghanistan Tax Law effective March 21, 2009, Jhpiego is required to withhold "contractor" taxes from the gross amounts payable to all Afghan for-profit subcontractors. In accordance with this requirement, Jhpiego withholds two percent (2%) tax from all gross invoices to Afghan subcontractors under this agreement with active business registration license The Jhpiego-HEMAYAT Project is exempt from cooperating country taxes, duties, and VAT.
- <u>Eligibility</u>: By submitting an offer in response to this RFQ, the offeror certifies that it and its principal officers are not debarred, suspended, or otherwise considered ineligible for an award by the U.S. Government. Jhpiego-HEMAYAT project will not award a contract to any firm that is debarred, suspended, or considered to be ineligible by the U.S. Government.
- <u>7.</u> <u>Terms and Conditions</u>: This is a Request for Quotations only. Issuance of this RFQ does not in any way obligate Jhpiego HEMAYAT Project, or USAID to make an award or pay for costs incurred by potential offerors in the preparation and submission of an offer. This solicitation is subject to Jhpiego-HEMAYAT' standard terms and conditions. Any resultant award will be governed by these terms and conditions; a copy of the full terms and conditions is available upon request. Please note the following terms and conditions will apply:
- **8.** Any award resulting from this RFQ will be firm fixed price, in the form of a purchase order.
- <u>9.</u> No commodities or services may be supplied that are manufactured or assembled in, shipped from, transported through, or otherwise involving any of the following countries: Burma (Myanmar), Cuba, Iran, Iraq, Laos, Libya North Korea, (North) Sudan and Syria. Any international air or ocean transportation or shipping carried out under any award resulting from this RFQ must take place on U.S.-flag carriers/vessels.
- <u>10.</u> Penalty Charges: Jhpiego will add a clause to the purchase order for the selected entity as the result of this RFQ and may deduct a sum up to **2% of the Purchase Order** ceiling amount for each day of delay beyond the agreed delivery time until the actual goods/service received.
- 11. Non. U.S. third party vetting: For every purchases above \$25,000 Jhpiego is required to conduct a vetting before signing a PO. The successful bidder will be requested to provide information which will be shared with the USAID vetting unit for vetting purposes.
