Instructions to Bidders:

Qualification Requirements	Bidders are required to submit the following documents to ascertain their qualification:
	 (a) Valid Tax Compliance Certificate. (b) Valid Business licence. (c) Authorized Representation in Afghanistan (d) Corporate Bank Account. (e) Copy of National Identity Card (NIC) and valid passport for vetting purposes. (f) Proof of 2 similar previous experiences proven (copy of Contract/recommendation letter) in provision and delivery of similar services in the last 2 to 3 years. (g) Submit physical address and contact details of office branches. (h) Annexes B & C duly filled, signed and stamped Failure to submit the required documentation above will result in disqualification from the bidding process
Determination of Bids	Prior to the detailed evaluation of bids, IDLO shall determine
Responsiveness	whether each bid
	a) has been properly signed;b) is substantially responsive to the requirements.
Bid Errors & correction	Bids determined to be substantially responsive shall be
	checked by the IDLO for any arithmetic errors. Errors shall
	be corrected by the IDLO as follows:
	 a) where there is a discrepancy between the amounts in figures and in words, the amount in words shall govern; and b) where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted shall govern. c) The amount stated in the bid shall be adjusted by IDLO in
	accordance with the above procedure for the correction of errors and shall be considered as binding upon the Bidder. Bidders may revise their bids up to the closing date and time, revised bids should be clearly marked with "revised bid". No changes to bids will be accepted after the bid has closed, this includes any price revision.

The following Special Conditions of Contract shall supplement and/or amend the IDLO General Terms and Conditions for the Procurement of Services. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail over those in IDLO General Terms and Conditions for the Procurement of Services.

Place of delivery	IDLO Kabul Office, located at The Baron Kabul, near KIAA/RS Abbey Gate, Hawa-e-Shanasi Road, Khawaja Rawash, Kabul, Afghanistan
Delivery date	The service contract will be signed for a period of up to 12 months. IDLO is not obliged to use the services provided by the Contractor. IDLO will review the quality of services and deliverables after 12 months. Subject to satisfactory performance and agreement by both parties the service contract may be extended for another 12 months. The overall duration of the contract will not exceed 24 months. The prices will remain unchanged during the period of contract
