Samples: For items included in this RFQ samples are required to be inspected by HN TPO Kabul office procurement committee members for selection

Warranty: supplier has to provide standard business warranty for all quoted items but it should not be less than one year.

Payment: The payment will be done 100% after the goods receipt, inspected, quality checked and accepted.

Tax: 2% tax amount will be deducted from the total cost of the bid price from registered suppliers with AISA or MOC & 7% from unregistered suppliers as Afghanistan government tax law.

Delivery Location: All goods to be delivered no later than specified period from the date of signing of purchase order.

Delivery Time: If the items are not delivered according to the delivery time, HNTPO has the rights to cancel the purchase order and the company will be black-listed with HNTPO for future business.

Experience: The company should have at least three years similar experience and the copy of contracts should be submitted.

Incoterm: The goods will be delivered under DDP Incoterms 2020 to HealthNet TPO Office, House# 144, Street#5, District-3, Dehbur, Deh Naw, Kabul Afghanistan.

Inspection: The goods will be inspected according to the specification by HNTPO technical team.
