## I. Introduction and Purpose

## I.I Purpose & Background

DAI, the implementer of the USAID-funded project Afghanistan Value Chains-Livestock (AVC-Livestock), invites qualified offerors to submit proposals to provide services for the completion of the Women's Entrepreneurship Development Program – Phase II, in supporting women and youth enterprises to start and improve their business through provision of business incubation.

AVC-Livestock is a 5-year, USAID-funded market-oriented program which operates throughout the country, with regional offices in Kabul, Herat, Mazar-e-Sharif, Jalalabad, and Kandahar. AVC-Livestock utilizes a market systems approach to strengthen and facilitate key transactions at either end of the farmer in targeted value chains - the commercial vendors of the goods and services that farmers need to grow higher volumes of quality produce, and the processors and traders who purchase farmers' harvests. AVC-Livestock is a market-driven, private sector-focused program that aims to sustainably strengthen the dairy, poultry, honey, red meat and fiber value chains throughout Afghanistan resulting in increased incomes, employment and productivity throughout targeted value chains.

## I.2 Issuing Office

The Issuing Office and Contact Person noted in the above synopsis is the sole point of contact at DAI for purposes of this RFP. Any prospective offeror who fails to register their interest with this office assumes complete responsibility in the event that they do not receive direct communications (amendments, answers to questions, etc.) prior to the closing date.

## **I.3** Type of Award Anticipated

DAI anticipates awarding a Firm Fixed Price Purchase Order (FFPO).

## 2. General Instructions to Offerors

#### 2.1 General Instructions

"Offeror", "Subcontractor", and/or "Bidder" means a firm proposing the work under this RFP. "Offer" and/or "Proposal" means the package of documents the firm submits to propose the work.

Offerors wishing to respond to this RFP must submit proposals, **in English**, in accordance with the following instructions. Offerors are required to review all instructions and specifications contained in this RFP. Failure to do so will be at the Offeror's risk. If the solicitation is amended, then all terms and conditions not modified in the amendment shall remain unchanged.

Issuance of this RFP in no way obligates DAI to award a subcontract or purchase order. Offerors will not be reimbursed for any costs associated with the preparation or submission of their proposal. DAI shall in no case be responsible for liable for these costs.

Proposals are due no later than **4:30 PM Kabul local time on August 3, 2020**, to be submitted through AVC-L\_ProcurementInbox@dai.com. Late offers will be rejected, except under extraordinary circumstances at DAI's discretion.

The submission to DAI of a proposal in response to this RFP will constitute an offer and indicates the Offeror's agreement to the terms and conditions in this RFP and any attachments hereto. DAI reserves the right not to evaluate a non-responsive or incomplete proposal.

#### 2.2 Proposal Cover Letter

A cover letter shall be included with the proposal on the Offeror's company letterhead with a duly authorized signature and company stamp/seal using Attachment B as a template for the format. The cover letter shall include the following items:

- The Offeror will certify a validity period of **90 days** for the prices provided.
- Acknowledge the solicitation amendments received, if any.

### 2.3 Questions regarding the RFP

Each Offeror is responsible for reading and complying with the terms and conditions of this RFP. Requests for clarification or additional information must be submitted in writing via email specified in the Synopsis above. No questions will be answered by phone. Any verbal information received from a DAI or AVC-Livestock employee or other entity shall not be considered as an official response to any question regarding this RFP.

Copies of questions and responses will be distributed in writing to all prospective bidders who are on record as having received this RFP after the submission date specified in the Synopsis above.

## 3. Instructions for the Preparation of Technical Proposals

Technical proposals shall be sealed in a separate envelope from cost/price proposals and shall be clearly labeled as "VOLUME I: TECHNICAL PROPOSAL".

Technical proposals shall include the following contents:

- Technical Approach Description of the proposed services which meets or exceeds the stated technical specifications or scope of work. The proposal must show how the Offeror plans to complete the work and describe an approach that demonstrates the achievement of timely and acceptable performance of the work. The technical approach should explicitly state how the Offeror will implement (technically and logistically), monitor, and evaluate the activity.
- 2. Management Approach Description of the Offeror's staff assigned to the project. The proposal should describe how the proposed organizational structure and team members have the necessary experience and capabilities to carry out the Technical Approach. The Management Approach should include a detailed organizational scheme/chart in addition to copies of CVs for high-level team members and critical personnel components of the project.
- 3. Past Performance Provide a list of at least five (5) awards of similar scope and duration, recent awards preferred. The information shall be supplied as a table and shall include the legal name and address of the organization for which services were performed, a description of work performed, the duration of the work and the value of the contract, description of any problems encountered and how it was resolved, and a current contact phone number of a responsible and knowledgeable representative of the organization. Past performance should be completed per the template given in Attachment D.

#### 3.1 Services Specified

For this RFP, DAI needs the services described in Attachment A, Scope of Work.

#### 3.2 Technical Evaluation Criteria

Each proposal will be evaluated and scored against the evaluation criteria and evaluation subcriteria, which are stated in the table below. Cost/Price proposals are not assigned points, but for overall evaluation purposes of this RFP, technical evaluation factors other than cost/price, when combined, are considered significantly more important than cost/price factors.

# 4. Instructions for the Preparation of Cost/Price Proposals

## 4.1 Cost/Price Proposals

Cost/Price proposals shall be sealed in a separate envelope from technical proposals and shall be clearly labeled as "VOLUME II: COST/PRICE PROPOSAL". Volume II should include the following:

- I. Price Schedule as provided in Attachment C;
- 2. Detailed Budget Breakdown of costs; and
- 3. Budget Narrative, explaining cost elements and deliverable costs as per both the Price Schedule and Detailed Budget Breakdown.

The Subcontractor is responsible for all applicable taxes and fees, as prescribed under the applicable laws for income, compensation, permits, licenses, and other taxes and fees due as required. Bidders are also responsible for compliance with USAID regulations requiring Defense Base Act coverage for staff. Information on DBA can be found in Attachment G.

## 5. Basis of Award

## 5.1 Best Value Determination

DAI will review all proposals, and make an award based on the technical and cost evaluation criteria stated above and select the offeror whose proposal provides the best value to DAI. DAI may also exclude an offer from consideration if it determines that an Offeror is "not responsible", i.e. that it does not have the management and financial capabilities required to perform the work required.

Evaluation points will not be awarded for cost. Cost will primarily be evaluated for realism and reasonableness. DAI may award to a higher priced offeror if a determination is made that the higher technical evaluation of that offeror merits the additional cost/price.

DAI may award to an Offeror without discussions. Therefore, the initial offer **must contain the Offeror's best price and technical terms.** DAI retains the right to make a full award, partial award, or no award. This may include, but is not limited to, making an award based on geographic and/or programmatic/technical best value to DAI and its client, USAID.

## 5.2 Responsibility Determination

DAI will not enter into any type of agreement with an Offeror prior to ensuring the Offeror's responsibility. When assessing an Offeror's responsibility, a site visit may be conducted, the following factors are taken into consideration:

- I. Provide evidence of the required updated business licenses to operate in Afghanistan.
- 2. Evidence of a DUNS number (Attachment G and H).
- 3. The source, origin and nationality of the products or services are not from a Prohibited Country (explained below).
- 4. Having adequate financial resources to finance and perform the work or deliver goods or the ability to obtain financial resources without receiving advance funds from DAI.
- 5. Ability to comply with required or proposed delivery or performance schedules.
- 6. Have a satisfactory past performance record, with previous awards of a similar scope.
- 7. The offeror is required to submit at least three copies of recent contracts along with contact details.
- 8. Have a satisfactory record of integrity and business ethics.
- 9. Have the necessary organization, experience, accounting and operational controls and technical skills.
- 10. Have the necessary production, construction and technical equipment and facilities if applicable.
- II. Be qualified and eligible to perform work under applicable laws and regulations.

## 6. Anticipated post-award Deliverables

Upon award of a subcontract, the deliverables detailed in Attachment C: Price Schedule will be submitted to DAI. The Offeror should detail proposed costs per deliverable in the Price Schedule. All of the deliverables must be submitted to and approved by DAI before payment will be processed.

## 7. Inspection & Acceptance

The designated DAI Project Manager will inspect the services being performed to determine whether the activities are being performed in a satisfactory manner. The Project Manager and his/her designee will also review and provide technical approval for deliverables. The subcontractor shall be responsible for any countermeasures or corrective action, within the scope of this RFP, which may be required by the DAI Chief of Party as a result of such inspection and review.

## 8. Compliance with Terms and Conditions

#### 8.1 General Terms and Conditions

Offerors agree to comply with the general terms and conditions for an award resulting from this RFP. The selected Offeror shall comply with all Representations and Certifications of Compliance listed in Attachment F.

#### 8.2 Source and Nationality

Under the authorized geographic code for its contract, DAI may only procure goods and services from **Geographic Code 935:** Goods and services from any area or country including the cooperating country but excluding Prohibited Countries.

DAI must verify the source and nationality of goods and services and ensure (to the fullest extent possible) that DAI does not procure any goods or services from prohibited countries listed by the Office of Foreign Assets Control (OFAC) as sanctioned countries. OFAC sanctioned countries may be searched within the System for Award Management (SAM) at <u>www.SAM.gov</u>. The current list of countries under comprehensive sanctions include: Cuba, Iran, North Korea, Sudan, and Syria. Goods may not transit through or be assembled in comprehensive sanctioned origin or nationality countries

nor can the vendor be owned or controlled by a prohibited country. DAI is prohibited from facilitating any transaction by a third party if that transaction would be prohibited if performed by DAI. By submitting a proposal in response to this RFP, Offerors confirm that they are not violating the Source and Nationality requirements of the goods or services being offered and that the goods and services comply with the Geographic Code and the exclusions for prohibited countries outlined above.

## 8.3 Data Universal Numbering System (DUNS)

There is a **mandatory** requirement for your organization to provide a DUNS number to DAI. The Data Universal Numbering System is a system developed and regulated by Dun & Bradstreet (D&B) that assigns a unique numeric identifier, referred to as a "DUNS number" to a single business entity. Without a DUNS number, DAI cannot deem an Offeror "responsible" to conduct business with and therefore, DAI will not enter into a subcontract/purchase order or monetary agreement with any organization. The determination of a successful offeror/applicant resulting from this RFP/RFQ/RFA is contingent upon the winner providing a DUNS number to DAI. Offerors who fail to provide a DUNS number will not receive an award and DAI will select an alternate Offeror.

All U.S. and foreign organizations which receive first-tier subcontracts/purchase orders with a value of \$30,000 and above **are required** to obtain a DUNS number prior to signing of the agreement. Organizations are exempt from this requirement if the gross income received from all sources in the previous tax year was under \$300,000. DAI requires that Offerors sign the self-certification statement if the Offeror claims exemption for this reason (Attachment H).

For those required to obtain a DUNS number, see Attachment I - Instructions for Obtaining a DUNS Number - DAI'S Vendors, Subcontractors. For those not required to obtain a DUNS number, see Attachment E: Self Certification for Exemption from DUNS Requirement.

## 9. Procurement Ethics

Neither payment nor preference shall be made by either the Offeror, or by any DAI staff, in an attempt to affect the results of the award. DAI treats all reports of possible fraud/abuse very seriously. Acts of fraud or corruption will not be tolerated, and DAI employees and/or subcontractors/grantees/vendors who engage in such activities will face serious consequences. Any such practice constitutes an unethical, illegal, and corrupt practice and either the Offeror or the DAI staff may report violations to the Toll-Free Ethics and Compliance Anonymous Hotline at +1 855-603-6987, via the DAI website, or via email to FPI\_hotline@dai.com. DAI ensures anonymity and an unbiased, serious review and treatment of the information provided. Such practice may result in the cancellation of the procurement and disqualification of the Offeror's participation in this, and future, procurements. Violators will be reported to USAID, and as a result, may be reported to the U.S. Department of Justice to be included in a Restricted Parties list, preventing them from participating in future U.S. Government business.

Offerors must provide full, accurate and complete information in response to this solicitation. The penalty for materially false responses is prescribed in Section 1001 of Title 18 of the United States Code.

In addition, DAI takes the payment of USAID funds to pay Terrorists, or groups supporting Terrorists, or other parties in exchange for protection very seriously. Should the Terrorist, groups or other parties attempt to extort/demand payment from your organization you are asked to immediately report the incident to DAI's Ethics and Compliance Anonymous Hotline at the contacts described in this clause. By submitting an offeror, offerors certify that they have not/will not attempt to bribe or make any payments to DAI employees in return for preference, nor have any payments with Terrorists, or groups supporting Terrorists, been attempted.

## **10.1 Attachment A: Scope of Work**

## A. Background:

AVC-Livestock accomplished the first phase of Women Entrepreneurship Development Program in four regions (east, west, south and north) from June to October 2019 with the aim to integrate and enable women-owned agribusinesses to become part of the highly integrated livestock value chains by using a unique approach of learning-by-doing through provision of on-the-job trainings to over 100 employees of 40 women-owned livestock agribusinesses mainly focusing on organizational and business management, budgeting and bookkeeping, marketing, sales, and customer services among other topics.

During February 2020, the team conducted several follow up activities (meetings, interviews, Focus Group Discussions) with those women-owned businesses who directly befitted from the initiative in four mentioned regions. The overall feedback was highly positive. All the visited anchor firms have assured that the program has helped them generate concrete business ideas for improving their existing businesses and creating new enterprises which have, in turn, lead to significant revenue and employment generation. The regional members of AWCCI (Afghanistan Women Chambers of Commerce and Industries) have also expressed that the activity was indeed a flagship program designed to help women entrepreneurs become more competitive, achieve higher levels of business growth and become resilient in today's dynamic business environment.

Considering the very positive feedback from the field and as per the project's Annual Workplan, Year 2, this scope of work is designed for women/youth owned small companies to be trained on various important topics of Business Management in livestock value chains.

#### **B.** Goals and Objectives:

The goal of this activity is to support women and youth enterprises to start and improve their business through provision of business incubation services.

The specific objectives of this activity are to:

- 1. Enhancing the capacity of 40 women and youth enterprises as a key component in increasing opportunity, equality and inclusion for individuals and groups considering that women and youth also often do not have access to training in business management, finance, business planning, marketing and other important skills that would help them to plan, manage an existing agribusiness.
- 2. Facilitate the vertical integration of women in the livestock value chain by providing them with market information and specifications through provisions of a comprehensive business incubation which will better prepare women owned businesses to meet buyers' expectations and give them equal access to market opportunities.
- 3. Advise the selected Women's firms on how to manage their respective businesses, to better understand their products and the competitive advantage derived from aggregation and bulk procurement and sales.

#### C. Scope of Work:

AVC-Livestock will identify 40 women owned businesses from various provinces to actively participate in the program based on a set of criteria.

The sub-contractor will be responsible for the provision of the following:

#### I. Implementation Plan:

The detailed Implementation Plan should cover all activities: start-up plan, training sessions, ceremonies, operational preparedness, travel arrangements, technical preparedness, and reporting schedule. The Implementation Plan will also include draft monthly/final report formats for approval by AVCL.

#### 2. Curriculum Development:

Design and Introduce a comprehensive curriculum covering the following key topics:

- a. Business Plan Development
- b. Finance and Costing
- c. Marketing
- d. Operation Management

AVC-L Gender Unit will review and (if needed) modify the curriculum to sensitize it for specific AVC-Livestock requirement of selected women enterprises. Bidders should note if this is an internally developed curriculum or an off-the-shelf product in their proposals. Either option is technically acceptable.

#### 3. Training Events:

Delivery of a comprehensive training for each women group. The vendor shall propose the number of training days for each group, depending on their methodology and approach. The training will mainly cover business management, financial literacy, business planning and marketing. A total of 100 women divided in 4 groups will be introduced by AVC-L to attend this training in the below mentioned provinces. Each group will include 25 women from different value chains and different regions as follows:

- Nangarhar One group (Dairy, Poultry, Small Ruminant and Honey)
- Balkh One group (Dairy, Poultry, Small Ruminant and Honey)
- Herat One group (Dairy, Poultry, Small Ruminant and Honey)
- Kabul One group (Dairy, Poultry, Small Ruminant and Honey)
- Note: The sessions should be based in the capital city of the mentioned provinces.

#### 4. Reporting:

Provide a detailed final report after each group has completed their training including: attendance sheets of all trainings, photographs, lessons learned, recommendations, and any other supporting documents and sections as applicable.

#### 5. Travel, Operations, and Logistics:

The offeror is expected to cover all associated costs for the training and preparation of materials. Costs will include, but are not limited to the following:

- Venue for each training;
- Lunch and refreshments for all participants;
- Materials (Printed documents, IT equipment, projectors, etc.);
- Personal Protection Equipment (Bidders must include the costs of issuing face masks to all participants and have alcohol-based hand sanitizer available at all events);
- Trainee Travel Costs: Payment of travel costs for trainees to attend event (AVC-Livestock will not consider individual costs higher than 10 USD per trainee); and
- All/any other costs associated with the training.

#### D. Monitoring and Evaluation:

A successful bidder will provide AVC-L with a clear and concise M&E implementation plan as part of their technical proposal. This plan must include the submission of a comprehensive M&E training report at the completion of each training – this can be included within the final report as noted above. The bidder will also need to demonstrate their M&E approach and plan as part of the technical proposal.

AVC-L's, MEL staff will also closely monitor the implementation progress and verify AVC-L's performance indicators data using the approved data collection methods and instruments. Several feedback meetings and focus group discussions will be conducted after the completion of the activity to maintain the relationship and check on the outcome of the activity.

Specific for M & E:

- Provision of the implementation plan/schedule of the assignment to AVC-Livestock M&E team
- Assist and fully involve AVC-Livestock M&E team in all aspects of implementation.
- Provide regular progress reports (inception report, monthly progress and completion reports) to AVC-Livestock
- Provide regular environmental compliance reports (weekly updates, monthly and final environmental compliance reports) to AVC-Livestock Environmental Compliance Specialist.

#### E. Expected Outcomes

Including, but not limited to:

- Enhance the capacity of forty (40) women-owned businesses in business improvement, generating innovative business ideas to start a successful business.
- The activity will mainly cover business management, financial literacy, business planning and market requirements for women and youth and will offer business development support for a minimum of forty (40) women and youth owned anchor firms covering a total number of one hundred (100) employees.
- Generation of, at minimum, 3 success stories

AVC-Livestock will follow up with the targeted women owned business to measure their revenue growth within three months after graduation. Building the capacity of women and youth is a key component increasing opportunity, equality and inclusion for individuals and groups. As with their counterparts, women and youth also often do not have access to training in business management, finance, business planning and other important skills that would help them to plan, start and/or manage an existing home based or formal business. AVC-Livestock will target women owned businesses from the five AVC-Livestock target value chains.

#### F. Technical Direction

Technical direction and management of this activity will be done by the Gender & Youth Director and/or his/her designee.




