3. Bidding will be conducted through National competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" August 2018 ("Procurement Regulations") and is open to all eligible Bidders as defined in the Procurement Regulations.

The bidding document in English may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of [4,000 AFN]. The bidder shall quote only in Afghani. The bids received in any other freely convertible currency (maximum up to three) will be converted to Afghani as per rate of exchange (selling rate) published by the Da Afghanistan Bank based on rate of exchange (Transfer Selling rate) prevailing on the date of bid closing and contract will be concluded in AFN.
6. Bids must be delivered to the address below on or before **10:00 AM Kabul time** on the **August 12, 2020**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below.
7. All Bids must be accompanied by a Bid Security from a reputed valid Bank. The Bid Security amount **112,000.00 AFN**
