(4) Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the government of a covered foreign country.

- **Tax:**

According to Article 72 of Afghanistan Income Tax Law of Islamic Republic of Afghanistan, DT Global Inc must withhold a certain percentage based on gross payment made to the subcontractor and transfer that amount, on behalf of the contractor, to the Ministry of Finance’s relevant account. For businesses without a valid business license, 7% of the gross payment to the contractor shall be withheld as fixed tax in lieu of income tax.
