Supply, installation and commissioning of Enterprise Resource Planning (ERP) software for Badakhshon Energy Company

Badakhshon Energy Company (BE), a subsidiary of the Aga Khan Fund for Economic Development (AKFED), is an energy utility company operating in the Badakhshan Province of Afghanistan. Based on 30-year concession agreement, the Government of Afghanistan has handed over the operation of Badakhshan's energy system to BE. BE's goal is to bring clean, reliable and affordable electricity to every household in the Badakhshan Province.

The Aga Khan Foundation (AKF) USA has set aside an award for BE and Pamir Energy (PE) to implement the Local Impact Project. Through the Local Impact project, PE and BE aim to establish a strong foundation for the sustainable development of a resilient energy provision system in the Badakhshan Province of Afghanistan through the establishment of an integrated utility model. AKF USA will serve as managing partner and lead for PE TAJIKISTAN/BE AFGHANISTAN as the sub-recipient in implementation of this program's activities according to its Partner Scope of Work.

Through current tender, BE intends to acquire ERP application to manage accounting of expenditures, sales and receivables, payables, banks, cash, stores, payroll, procurement of the Badakhshon Energy Company. BE would like to setup the ERP application which best fit its needs. In anticipation of rapid growth, the company wants a platform that can scale up and is flexible and agile. The ERP should also need to support Badakhshon Energy's complex entity structure, including the ability to perform multilevel consolidations, handle multiple charts of accounts, and analyze business information across multiple dimensions including region, location, and line of business.

- 1. PE/BE now invites sealed bids from qualified bidders for the Supply, installation and commissioning of Enterprise Resource Planning (ERP) software for Badakhshon Energy Company.
- 2. Bidding will be conducted through the International Competitive Bidding (ICB) procedures in accordance with the procurement policies of the PE/BE and is open to all bidders.
- 3. Interested bidders may obtain further information from Regional Projects Implementation Unit (RPIU) of PE, and inspect the Bidding Documents at the address given below.
- 4. Documents can be obtained from RPIU in English language by interested bidders upon submission of request to the below mention addresses.
- Sealed bids must be delivered to the addresses below in English language no later than October 1st, 2020 14.00 hours Dushanbe time or 13.30 hours Kabul time.

- 6. Electronic bids can be submitted by the international bidder following the instructions on the tender documents. Late bids will be rejected.
- Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at 16.00 hours Dushanbe time or 15.30 hours Kabul time, on October 1st, 2020.
