Roots of Peace (ROP) is a humanitarian organization whose mission is to rid the world of landmines and other remnants of war by transforming toxic minefields into thriving farmland and communities through a focus on sustainable, organic farming practices. Roots of Peace implementing community base agriculture rural development (CBARD) project to support the Production of Fruit and Vegetables as an alternative to poppy Cultivation and Trade in three high Cultivation provinces of Afghanistan.

The Project support cold chain facilities to bring to Market Afghan fruit and vegetables. This will allow traders to source licit crops such as fresh fruits and vegetables from CBARD provinces while minimizing loss and deterioration. Exporting better quality products to international markets is expected to lead to higher incomes for CBARD farmers and promote licit trade. The project will also focus on strengthening the human and institutional capacity of the Afghan Ministry of Agriculture, irrigation & Livestock (MAIL).

Moreover, the CBARD-AIM project will create a partnership between existing CBARD communities to reach three key objectives: reducing opium poppy cultivation, create licit economic development for former poppy farmers and women in the community, and supporting more sustainable peace.

## A. INSTRUCTION TO BIDDERS

1. Should hold valid AISA registration or registration with the respective ministry.
2. Has a valid tax clearance certificates from ministry of finance-Afghanistan.
3. The quotation must include the taxes as per Afghanistan tax law. ROP CBARD will not accept any additional taxes or changes to the awarded entity after an award is made.
4. According to GOIRA Tax Law, ROP-CBARD will withhold 2% tax of the gross amount from provider who has valid registration license with the relevant afghan ministries and remit the amount to ministry of finance and 7% tax from those who don't have registration licenses.
5. ROP-CBARD reserves the right to reject the product supply if it doesn't meet the required specifications described in this solicitation
6. No advance payment will be made.
7. Payments will be made to the provider by bank transfer, ROP CBARD will pay the provider in accordance with the payment schedules as stipulated in the Purchase order agreement within 30 days of submission of an acceptable invoice by the provider and ROP CBARD acceptance of the service.
8. Incomplete and non-compliant offers will not be considered.
9. The supplier must provide sample for committee approval.
10. The requested items must be delivered to ROP-CBARD Office Kabul.
11. The product must be brand new. Used and refurbished item will not be accepted.
12. The company should provide two years of financial report along with the bank statement.

## B. Submission of offers

Submit signed, dated and stamped quotations in this RFQ format with your offers to designated committee member/s or Procurement team before deadline specified in this solicitation. The Subject Line must be the **(RFQ-CBARD-2020-024)**, failure to adhere this instruction may lead to disqualification of a quotation.

Please note that all quotations must be submitted in English.

Best offer proposals are requested. It is anticipated that a contract will be awarded solely on the basis of the original offers received. However, ROP CBARD reserves the right to conduct discussions, negotiations and/or request clarifications prior to awarding a contract.

## C. Offer Format

Offerors are required to format their submissions in accordance with the instructions and requirements described in this RFQ. Failure to adhere to these instructions or requirements may lead to disqualification of a quotation from evaluation:

- Prices quoted in response to this RFQ must be priced in USD.
- Proposed Payment Terms.
- Warranty Terms and Conditions.
- Lead time for delivery to pick-up location.
- Validity period for quotation.

#### D. Questions on the RFQ

- Offerors are welcome to seek clarifications or ask questions on the technical and administrative aspects of this RFQ.
- All questions or requests for clarification must be in English.
- Questions or requests for clarification should be submitted in writing by email only, by the deadline, and to the email address stated on the cover page of the RFQ.
- Offerors should be aware that their responses to questions or requests for clarification may be shared with other Offerors.
- Any verbal information received from employees of ROP-CBARD the Beneficiary or any other entity should not be considered as an official response to any questions regarding this RFQ.

#### E. Pricing

- All prices presented in a quotation should be firm, fixed and all-inclusive. No additional sums will be payable for any change or escalation in the cost of materials, equipment, packaging or labor, warranty-related costs and charges, and, any and all other costs and charges of whatever description or amount in connection with, necessary for, or resulting from the Offerors' required performance.
- Prices must include all taxes required by the Country in which the factory or assembly works. ROP-CBARD will not accept any additional taxes or changes after any resulting award.

#### F. Sources and Nationality

The vendor may not supply any goods or services manufactured in or shipped from the following countries: Cuba, Iran, Laos, Libya, North Korea, or Syria.

Note: Chinese Brand Electronic Instruments will not be accepted.

#### G. Evaluation and Award

The award will be made to a responsible offeror whose offer follows the RFQ instructions, meets the eligibility requirements, and meets or exceeds the minimum required technical specifications, and is judged to be the best value based on a lowest-price, technically acceptable (LPTA) basis.

Please note that if there are significant deficiencies regarding responsiveness to the requirements of this RFQ, an offer may be deemed "non-responsive" and thereby disqualified from consideration. ROP-CBARD reserves the right to waive immaterial deficiencies at its discretion.

- C. ROP CBARD reserves the right to cancel this RFQ at any time.
- D. ROP CBARD reserves the right to reject any or all bids without assigning any reasons.
- E. ROP CBARD reserves the right to waive any administrative requirement in this RFQ.
- F. If the Offeror anticipates subcontracting any of the work to a subcontractor, the Offeror must provide details of the subcontractor to ROP CBARD to for approval.
- G. All Goods (including, but not limited to, materials, parts, components, and sub-assemblies thereof) shall, unless otherwise expressly approved by ROP CBARD to in writing, be new, and not used, remanufactured, refurbished or discontinued; and shall be produced entirely from goods meeting all of the foregoing requirements.
- H. ROP CBARD will have the right to carry out due diligence on any offer received.

- I. ROP CBARD will not share its internal evaluation documents.
- J. According to income tax law of GoIRA, CBARD will deduct/retain 2% of the total contracting amount for suppliers with registration licenses and remit the amount to MoF.
- K. Suppliers without registration licenses will be deducted 7% of the total contracting amount and remit the amount to MoF.
