All bidding documents shall be submitted, **signed and stamped**, as **PDF only**. Documents submitted in other formats will be considered invalid.

The bids will be accepted only if the Email subject line indicates the respective Co-Soft. No.

The period for submission of Tender shall expire with the date and time mentioned under clause 1. Tenders may be withdrawn by email including letter prior to the submission time and date.

The period of adjudication begins with the submission / opening date and expires **60** calendar days later on in **November/** 2020. The Tenderer is bound to his Tender until this date.

Your confirmation of the receipt of the tender documents would be appreciated. If you are not interested to submit a Tender, please return the enclosures blank as soon as possible.

All questions in regard to that tender (technical and financial) please send in written but no later than **04.11.2020** at the aforementioned e-mail address. While inquiring about the bid, your subject line must indicate the Co-Soft Number . Your question can only be answered, If the respective Co-Soft number is mentioned in the subject line.

5. Price offer

The price offer must be submitted in AFN in accordance with Terms of Reference & Price Sheet and general Terms and conditions 5. In addition.

“All prices (unit prices, lump-sum prices, settlement rates, hourly wages, and bonuses) shall be stated with tax, according to the income law of Afghanistan. (Including all tax according to §72 income tax manual / Ministry of Finance; Islamic Republic of Afghanistan; May 2010)”.

Please see the attached Terms of Reference for details of the required quantities / personal & materials needed. Personnel costs should be shown on the basis of months of 30 days each.

6. Evaluation of Offer

Following presentation of the technical assessment, the quoted prices from those bidders which meet the technical criteria shall be opened and evaluated by the officer responsible for commercial matters. The technical bid is weighted at **70** and the price at **30**

This will result in an overall ranking, which will be headed by the most economically efficient bid. As a rule, contract negotiations shall be entered into with the first bidder in the ranking. In the event of failure of these negotiations, the next lower bidder in the ranking shall be invited to negotiate.

7. Further Information

Alternative bids are not allowed to be attached.

The tendering is made based on public tender, the awarding procedure after evaluation and eventually negotiation with one or more bidders.

The offer should follow the given structure and prices shall be quoted in **Afghani**. (AFN)

The opening of the sent bid documents will be held with GIZ members only.

The sent offer will be evaluated according to financial & Technical criteria only. That evaluation results in an economical ranking. Probably a bidder meeting will be held with the company offering the most economical bid. The announcement of the winner will be most probably on **01.01.2021**.

The winner might start his work **immediately after announcement**.

For the prepared offer and its attachments no compensation will be paid by GIZ. The sent offer together with documents attached will become property of GIZ.
