All Bidders must have a Business license valid for (2021-2022), comply with role and regulation of Afghanistan government and must be regular tax- payer to the government of Afghanistan,

6. Currency of the Bid:

Currency for this bid is Afghani and all financial rates and amount entered in Price proposal must be expressed in local Currency (Afghani).

7. Bid Price

Bidders are requested to provide the quotes for each item in price proposal and unit price will be the basis for evaluation in case of price discrepancy between unit price and Grand Total the unit price will be considered.

8. Documents Comprising the bid:

The submitted bid through bidders must include the following information failure to provide all documents may lead the supplier to disqualification

9. Bid Security:

Bid Security is not applicable for this RFP.

10. Bid Validity:

Bids must remain valid for 90 days after the bid opening date. Bids valid for shorter period may be rejected by committee.

11. <u>Tax:</u>

Pursuant to Article 72 in the Afghanistan Tax Law effective March 21, 2009, PARSA is required to withhold "contractor" taxes from the gross amounts payable to all Afghan for-profit subcontractors/vendors. In accordance with this requirement, PARSA shall withhold two percent (2%) tax from all gross invoices to Afghan subcontractors/vendors under this Agreement with active AISA or Ministry of Commerce license.

For subcontractors/vendors without an active AISA or Ministry of Commerce license, PARSA shall withhold seven percent (7%) "Contractor" taxes per current Afghanistan Tax Law.

- In case of price discrepancy between unit price and Grand Total the unit price will be considered.

 - The bidder's proposal must include technical and financial proposal in separated sealed envelopes
 - Bidders must sign the register form at gate while submitting their bids and clearly indicate Company name, address, representative name, Phone Number and Date of Submission.


