The above services requirements have the following specifications:

- 1. The contract shall be for 6 months (March to August 2021). Upon successful delivery of the requested deliverables providing these are to the Client's satisfaction, the Client will pay the Service Provider in accordance with the Purchase Order and Invoice.
- 2. All top-up cards should be in a useable condition.
- 3. Cards will be purchased on a monthly basis in accordance with Integrity Watch's needs.
- 4. All cards should be in hard form each having worth of 250 AFN.
- 5. Any top-up cards which cannot be used will be rejected by the Client and payment will not be made by the Client for these.
- 6. Payment will be made in accordance with the financial rules and procedures of the Client after issuance of invoice by Bank Transfer/Cheque.
- 7. The Client's Procurement Committee reserves the right to compare the prices in the market whenever they feel the need to.
- 8. The service provider will deliver top-up cards on a fixed price (Offered in RFQ) in accordance with the Purchase Order of Integrity Watch.

Requirements:

The Service Provider shall:

- Sign and stamp their bid and clearly mention the date.
- State clearly in writing the amount per unit and the total in AFN.
- Attach their company profile (past experience, license, value of previous contracts etc.).
- Write Integrity Watch's bid number (IWA/B2-21/TUC) on your offer.
