Site visits to verify the info will be conducted, therefore, provide valid address and phone numbers.</li> <li>Must have a valid local business registration license</li> <li>Must have a valid local business bank account</li> <li>Must provide three references</li> </ul>

Required Documents for Submission	<ul> <li>Please fill out the Vendor Form below and submit it along with the following documents only: <ol> <li>Completed, signed and stamped Vendor Info Form</li> <li>Valid Business Registration License</li> <li>Valid Business Bank Account Details</li> <li>Photo of the shop from outside with the business name captured</li> <li>Any other relevant business details that the vendor wants FHI 360 to know. For example, if a vendor is an authorized dealer for a particular brand, a copy of Certificate should be included.</li> </ol> </li> </ul>	

Vendor Review Process	<ul><li>FHI 360 will appoint a committee to review all responses received, will conduct site visit to verify the details provided, check the authenticity of the business license, reach out to provided references to verify past performance, seek any other clarification documents from vendor, if needed, and upon a positive verification, will authorize the vendor to be added to the FHI 360/Afghanistan vendor list.</li><li>Any vendor whose information FHI 360 cannot verify (i.e. no response to a phone number provided, wrong address provided) will be rejected and not added to the vendor list.</li></ul>	
	Any vendor that does not provide the required information, will be rejected.
